# The 10% Challenge

We introduced this challenge last month!

The SC Supreme Court has approved 6 CLE hours for lawyers who volunteer as poll workers! Find the required form and more info <a href="here">here</a>!!

Will you join the challenge? If so, please help us keep track of member participation by filling out this <u>form!</u>

We are challenging at least 10% of our members to volunteer on November 3rd! We are asking that each member commits to working, volunteering, on Election Day!

There are three roles for election day: poll watchers, boiler room attorneys, and hotline workers.

**1. Poll watchers** are needed statewide and will be assigned to polling precincts. Poll watchers will be stationed inside the precincts whenever social distancing guidelines can be met, otherwise, watchers can go outside. Poll watchers will receive training through SCDP VoPro, credentialing letters, badges, and face masks.

**2. Boiler Room attorneys** are needed statewide and will largely operate remotely, with the exception of some regional boiler rooms. This is a good opportunity for **law students** as well. Boiler room attorneys/law students may serve as rovers to go to polling locations where issues may be identified.
